



**KZIA, Inc. Contest Rules for

- 1) **NO PURCHASE NECESSARY:** No purchase is necessary to enter the contest and claim prizes.
- 2) **CONTEST DATES:** Monday, March 30, 2026, at 3 p.m. to Friday, April 3, 2026, at 7 p.m.
- 3) **CONDITION OF PARTICIPATION:** Materials submitted become property of KZIA, Inc. Winner may be required to execute an affidavit of eligibility and name and likeness publicity release and a waiver and release of liability.
